We further warrant that we have obtained any and all necessary permissions from third parties, insofar as required - to grant Yad Vashem usage of the Material, and that the use of the Material by Yad Vashem in accordance with the terms of this License and Consent Agreement shall not infringe any copyright, broadcasting right, distribution right, public performance right or other rights of any third party.
